A beneficiary is a designated individual or entity that will inherit the assets in your MERIT account. Use this form to indicate the beneficiary or beneficiaries that will receive your assets in the event of your death. If you do not designate a beneficiary or if all your primary and contingent beneficiaries predecease you, in the event of your death, your IRA will be paid to your estate.

This beneficiary designation overrides all previous designations for this IRA.
